ARPA's Annual Meeting will be held at 10:00 a.m. on Thursday, April 24 in La Junta. Please join the ARPA Board and staff to gain insight and to receive an update on the electric industry and board governance with guest speakers Tami Tanoue, General Counsel, CIRSA and Rob Wolaver, Energy Resources, Tri-State Generation and Transmission. Twin Eagle Power Supply Agreement - The Board of Directors at their meeting on March 27<sup>th</sup> approved an extension to its Partial Requirements Agreement with Twin Eagle Resource Management, LLC. The Amendment extends the term of the Agreement from January 31, 2022 through January 31, 2025. Twin Eagle will provide power supply, scheduling, and transmission services to the Authority beginning February 1, 2015. ARPA has not increased its base electric rates since 2011 and the pricing in this agreement will allow ARPA the ability to continue to provide stable electric rates for the foreseeable future.

Summary of February 2014 financial and operating statements - Total revenues for February exceeded budget projections by 2.9%. The total Cost of Goods Sold which includes purchased power, transmission, and wind turbine costs are well over budget due to the elevated cost of market power which was 80% higher this year than last year. This high market power was due to the volatility of natural gas prices from early January through the middle of March. The remainder of the power supply and general operating expenses, including ARPA's federal hydro-power allocation, was on or close to budget.

Supplemental Environmental Project Update – It appears there will be ample funds for the first phase of the community facilities lighting conversion that ARPA is funding. The first phase of the LED lighting conversion includes the libraries in ARPA's member cities. Savings from the library lighting conversions is estimated to reduce members lighting costs by over 40% and save over \$15,000 annually. Information is being collected for additional facility conversions such as community centers and senior centers.

Members Training – ARPA is sponsoring a training session for its member's line workers on bucket truck/pole top (hurt man) rescue in April. The training will be held in La Junta and provides an opportunity for the line crews from ARPA's members to work together and receive valuable life-safety training. Approximately twenty-five line crew personnel from the member cities will be attending the training.
