Twin Eagle Resource Management, LLC and Arkansas River Power Authority Enter into a Power Supply Agreement

Twin Eagle Resource Management, LLC (Twin Eagle), headquartered in Houston, Texas with offices in Denver, Colorado, and the Arkansas River Power Authority (Authority) have entered into a power supply agreement for the purchase and sale of electricity and related support functions.

Twin Eagle will provide power supply, scheduling, and transmission services to assist the Authority in its efforts to manage its electric rates for the next several years. Under the agreement, Twin Eagle will also schedule the Authority's federal hydropower resources and conduct energy accounting settlements for its members beginning in 2015 and extending into 2022.

The Authority provides wholesale electric energy to its member communities of Holly, La Junta, Lamar, Las Animas, Springfield and Trinidad, located in southeastern Colorado.

"We believe this is a very positive agreement for the Authority's member communities in that it will help us manage rate stability in an evolving and unpredictable energy environment," said Rick Rigel, general manager of the Power Authority. Rigel went on to say that "the ratepayers of the Authority's member communities will benefit from securing reliable electric power at fixed rates for the term of the Agreement."
